- To sign any papers, releases, and disclaimers that a doctor or hospital may want you to sign
- To consent to a minor child or children's admission to or discharge from any medical facility, including an emergency room (including transfer from one facility to another)
- To authorize or take part in discussions with any healthcare practitioner
- To provide your permission for any medical treatment or operation to be given, withheld, modified, or withdrawn

## EDUCATION

- To enroll the minor child or children in the proper educational setting or to access resources and standards for homeschooling

- To gain access to academic records of minor children
- To permit a minor child or children to participate in extracurricular activities or school
- To decide on any additional travel arrangements involving the minor child or the education of the kids

## **TRAVEL**

- To travel with the little child or children
- Making any necessary arrangements for the underage child or children, such as booking hotel rooms,

## **LIMITATIONS**

The temporary Guardian is not allowed to carry out the following tasks or actions:

I hereby declare and certify that the following statements are accurate to the best of my knowledge:

That I/we may exercise or grant the aforementioned rights and authority to the aforementioned Temporary Guardian without being hindered by any current court orders. (A copy of the court order appointing the Authorizing Party as the legal guardian or custodian of the aforementioned minor child or children shall be attached hereto.)

That I freely and voluntarily assign the aforementioned duties to care for the young kid or children, without being coerced, threatened, or compensated in any way.

That the person(s) we are designating as Temporary Guardian(s) will honestly and faithfully carry out the responsibilities outlined in this document and act in my/our child(reinvest )'s interest without any conflict of interest.

That the person(s) we are designating as Temporary Guardian(s) have never been the focus of a report or investigation into the abuse or maltreatment of a minor or been found guilty for those crimes; and that no one residing in (their) household has ever been the focus of a report or investigation for abuse or maltreatment of a minor or ever been found guilty for those crimes.

I shall give copies of the updated affidavit and the revocation to everyone I gave copies of the original affidavit to if I decide to change or revoke this Temporary Guardianship.

Temporary Guardianship shall become effective on 11/06/2024 and shall remain in full force and effect until 11/30/2025, or until such time as I, as the appointing Hunter Kai Hanson, notify the designated temporary guardian(s) in writing that this document has been amended or revoked.
